Digital Beef/New Registration Program

Amanda shared that often members do not assign a scrapie tag until an animal is sold or test DNA later after retainment or sale decisions are made and expect that they should be able to make those edits in the registry program. A short discussion followed, and the board agreed that members should have the ability to add scrapie tag and DNA info after the registration has been recorded.
