USSA Board of Directors Meeting

Monday, February 13, 2023 Meeting Minutes

President Ahart called the meeting to order at 7:31pm central.

Approval of the Agenda

Dennis Sorensen moved to approve the agenda as presented. The motion was seconded by Lloyd McCabe. All were in favor, motion carried.

Secretary's Report

Secretary Everts reported on registry work and discussed the directory. Directors were encouraged to share dates for zoom calls as zoom schedule remains active. Jeremy Geske moved to accept the Secretary's report, the motion was seconded by Carol Heupel. All were in favor, motion carried.

Treasurer's Report

Carol Heupel reported that the investment account balance is up about \$4,500 since the last meeting and \$10,000 has been moved to a cash account which is earning approximately 4% interest. Lloyd McCabe moved to accept the Treasurer's report, the motion was seconded by Jeremy Geske. All were in favor, motion carried.

Junior Report

Nancy Burton reported that the junior board has set fundraising goals and will begin to seek Suffolk semen donations for the AAJS semen fundraiser auction. The junior board has discussed the junior show to be held in conjunction with The Event in Springfield, Illinois. The virtual photo contest is underway.

Foundation Report

Brenda Reau reported the Foundation will be meeting very soon to discuss The Event and the Hall of Fame Dinner/Fundraiser.

Committee Reports

Budget – Carol Heupel reported the committee will meet soon and would like to possibly add an additional committee member.

Breed Improvement – Lloyd McCabe reported that the breed improvement committee recently met and reviewed the language recently adopted by the Southdown association. The committee proposed that the USSA adopt the same language. No action was taken.

Digital Suffolk

Diane Russell reported that the committee will meet within the next couple of weeks and will work on Event content and discuss the idea of creating a commercial ram record that members could purchase.

Strategic Planning

Jeremy Geske reported that committees are actively working on tasks from the strategic planning meeting.

Education

Dennis Sorensen reported that the education committee met and is working on the following topics: 1) commercial ram article, 2) maternal benefits of a Suffolk ewe, 3) narrative for Suffolk images, and 4) development of videos and reels for social media platforms. The committee will meet again later in February.

Event

Tom Begg reported on the planning progress for The Event. He asked directors to reach out to sheep friends to encourage attendance and help with fundraising. Subcommittees will be created for the sale, show and operations in addition to the Educational committee's

involvement. The Foundation will be approached for support. There was a brief discussion and brainstorming on different pieces of the event.

Marketing & Outreach

Brenda Reau reported that the membership benefits document will be sent out to state/regional Suffolk associations for use in their publications. The committee will discuss the newsletter in the upcoming meeting; evaluating whether it should contain ads or not. The committee has discussed renaming the directory as it is a more encompassing document that just breeder's contact information.

Old Business

North American Suffolk Sheep Society

There was discussion that the bylaws and breed standards had been posted.

January Membership Vote

Ballots were counted and the outcome is for no change in presentation at the National Show, National Sale and USSA online sales. There was discussion on membership communication.

District 1 Director Vacancy
